ANC3C RESOLUTION NO. 2008-042
Regarding Two Story Side Addition, Porch and Deck
At 3501 30th Street, N.W.

WHEREAS the owners of the residence at 3501 30th Street, N.W., which is located in the Cleveland Park Historic District, have applied to the Historic Preservation Review Board for permission to construct a two-story side addition, a shed dormer on the rear, an entrance porch on the front and a deck on the existing house;

WHEREAS 3501 30th St. N.W. is on the corner of Ordway and 30th Streets and, hence the south side of the house is clearly visible from Ordway Street;

WHEREAS the house immediately adjacent to 3501 30th Street, N.W. has a nearly identical front façade and does not have a covered front entrance porch and

WHEREAS the side addition projects only three feet from the width of the existing house and is set back a considerable distance from the front.

NOW THEREFORE, BE IT RESOLVED

1. That this ANC supports approval of the application.
2. That Commissioner Beckner, the Chair or their designee are authorized to represent the Commission in this matter.

BE IT FURTHER RESOLVED that the Chair, or the Commissioner for SMD 3C08, is authorized to represent the Commission on this matter.
