**SUPPORT OF RELOCATION OF ANNUAL EATON SALE/FUNDRAISER TO MACOMB
RECREATION CENTER BASKETBALL COURT FOR 2009**

WHEREAS the John Eaton Elementary School holds an annual Christmas tree sale and fundraiser in the school playground; and

WHEREAS the John Eaton Elementary School playground is currently under reconstruction and thus, there is no possibility of holding the Christmas tree sale there this year; and

WHEREAS the John Eaton Elementary School has asked the DC Department of Parks and Recreation if they could relocate the sale to the basketball court at the Macomb Recreation Center, which is a short distance from John Eaton; and

WHEREAS the John Eaton Elementary School has sought and received support for the relocation from the ANC SMD commissioner and the Macomb Recreation Center friends' group, ROMP; and

WHEREAS the John Eaton Elementary School sale and fundraiser will be held from December 10 to 13, 2009 and from December 18 to 20, 2009; and

WHEREAS the John Eaton Elementary School will secure the trees in the basketball court area and will not affect other areas of the Macomb Recreation Center; and

WHEREAS the sale and fundraiser is a popular and well-established community event:

BE IT RESOLVED that ANC 3C supports the relocation of the John Eaton Elementary School Christmas tree sale and fundraiser to the Macomb Recreation Center basketball court for 2009.

BE IT FURTHER RESOLVED that the Chair and Commissioner MacWood are authorized to represent the Commission on this matter.
